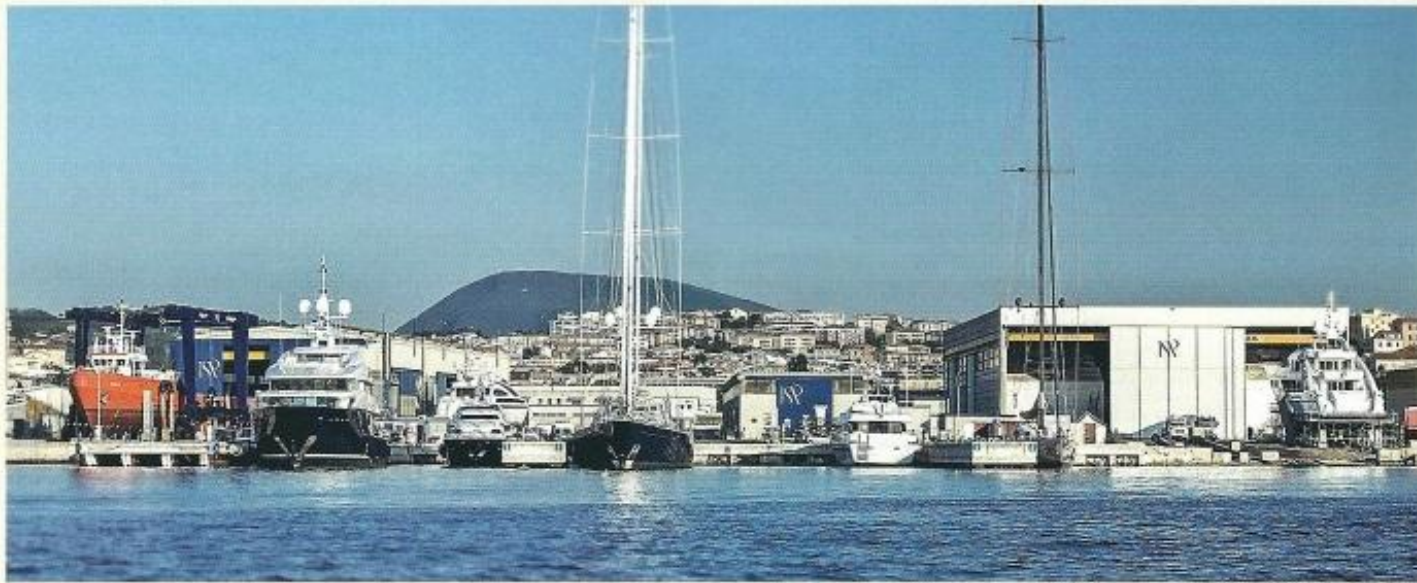

New owner of ISA Yachts

Explorers from dahm international ■ CDM sells 14 yachts ■ Piening DNV GL Certification



ISA Yachts: the Ancona-based builder filed for bankruptcy in 2015 and has been auctioned. A large number of bidders were interested in the brand, the four production buildings and unfinished new-builds. The Court in Ancona accepted a bid from the Palumbo Group.

ISA Yachts was acquired at the start of August by the Palumbo Group, which operates facilities in Naples, Marseille and Malta and manufactures new-build yachts with LOAs of between 40 and 57 metres under the Columbus Yachts brand. ISA Yachts had to file for bankruptcy last year and was subsequently approved for auction by the Court in Ancona. Plenty of bidders were interested in the ISA brand and the production facility that went with it, including all its unfinished new-build projects. The Ancona port authority has now transferred the lease agreement for the land on which the ISA buildings stand to the Palumbo Group as the new owners and extended the agreement by a total of 30 years. The plan is to start building new ISA yachts again in the ISA buildings soon. isayachts.com
